Another team work job from PD RENO and PD CAGNEY.

Following a call to Police in the early hours of Thursday 23rd October about a male driving without a license and potentially in possession of a weapon, units were quickly deployed to the area. The suspect has then failed to stop for Police. The driver was pursued by Armed response units after reports of the driver threatening someone with a taser. The driver has decamped from the car and run into a wooded area. PD Reno tracked and located the male hiding in the woods, the taser was also located in wooded area.

PD Cagney has searched the vehicle and the surrounding area and found a quantity of Class A and B drugs.

The male was arrested for multiple road related offensives, possession of an offensive weapon, possession of bladed article, PWITS Class B, possession of Class A and assault by beating and remains in custody at this time.

APPEAL | Footage sought following burglary series

Detectives have launched an investigation into a series of burglaries which have occurred in East Cornwall.

As part of our investigation, we are seeking dashcam footage from anyone who was driving along Well Lane, which is the main road between St Cleer and Tramar in Liskeard on Monday 20 October.

One of the incidents took place between 7.20am and 2.10pm on Monday 20 October at a property on Well Lane in St Cleer, with another occurring between 9.30am and 1pm on Trecarne view, St Cleer. In both incidents, jewellery and cash was stolen.

Detective Inspector Claire Nicholls said: "We believe that both incidents are part of a wider burglary series in the area. Many of the incidents have taken place in Liskeard, but we also have reports of burglaries in Pelynt, Looe, Widegates, Menheniot and Polbathic.

"The incidents have increased in the past few weeks with thieves targeting rural and secluded properties often in the daytime. Many of the incidents result in jewellery and cash being taken.

"We are asking residents to come forward with any information, particularly if they have doorbell camera footage.

"We are also reminding locals to be vigilant about home safety, ensuring homes are secure. Please see further home safety advice [here](#).

A fake fly-tip was set up at Golitha Falls to raise awareness with passers-by about the impact of dumping waste and how easy it is to report.

Not only is it an eye sore, but fly-tipping can have links to organised criminality as well as environmental consequences and financial implications; all of which cause harm in our communities.

So here's what to do if you spot fly tipping:

- Report it to your local council
- If it's large scale, contact the Environment Agency
- If waste is causing an obstruction on a road or a fly-tipping crime is in progress, call us on 999
- You can also report 100% anonymously via Crimestoppers

4 vehicles were recorded exceeding the 30mph speed limit doing speeds between 35 & 38mph 🚫

These motorists will be receiving a letter explaining that they have been recorded as speeding and given education as a way of a positive outcome. 🚔

The Community Speed Watch is operated by volunteers who are dedicated to their communities and ensuring our roads are safe for all road users and pedestrians. Residents often raise concerns of speeding vehicles to Police at our local surgeries and to the Town Council. Therefore there is a need for the Community Speed Watch to operate in our area. This area is frequently used by children walking to school or catching buses to college, its vital road users adhere to the speed limits. 🚔
