Local updates on our priority areas:

Drugs

We have conducted three drugs warrants in the last month or so. Two suspects have been charged with possession offences.

Anti social behaviour

We have worked closely throughout the year with Kay Smith, ASB Officer for Camborne and Annabelle Lamy, ASB Officer for Redruth. Together we have implemented 5 Closure Orders and 6 Criminal Behaviour Orders.

Violence against women and girls

We have been working on plans for 2026 around licensing, making our streets safer and working with schools and colleges.

Serious violence including knife crime

We took part in a series of knife crime based proactive operations as part of the national intensification week in November, Op Sceptre. Several knives were seized and taken off the streets.

We have a new PCSO joining us for training on 29th December. She will be covering Pool area after her tutorship.

We also have PC Kirstie Metcalf starting in January, also covering Pool and villages/rural areas.

Protect your presents – don't gift wrap them for thieves!

The festive seasons can bring lots of new and exciting gifts, but they also catch the eye of opportunist thieves. A few simple precautions can help keep your gifts safe.

- Don't leave your presents on display. Keep gifts out of sight from windows to avoid attracting unwanted
- Dispose of packaging carefully. Boxes for high value items left outside your home can advertise when you have inside
- Register your expensive items online. This can help us to identify the rightful owner if they are lost or stolen:
 - o Electronics log the item(s) serial number online with the 'UK National Property Register.'
 - o Bikes add your bike details to the 'National Police-Approved database.'

Do you know the law around using e-bike and e-scooters legally?

E-bikes and e-scooters can be a popular choice for presents during this festive season, but it's important that before using or buying them that you know the law.

Here's what you need to know about e-bikes:

You can ride an e-bike without a license or insurance if you're 14 or over, providing that it:

- Has pedals that you can use to propel it
- Has a 'continuous rated power' output of no more than 250 watts.
- Does not deliver electrical assistance once you reach 15.5 miles per hour (mph).

E-bikes must only be ridden on cycle paths and anywhere else pedal bikes are allowed.

If the e-bike doesn't meet the above criteria, the e-bike is actually classed as a motorbike or moped and must only be ridden on the road. To ride it legally, you must have a valid driving licence, insurance and you must wear a motorcycle helmet.

Know the laws around using e-scooters:

E-scooters are classed as motor vehicles under the Road Traffic Act 1988. It's currently not possible to get insurance for privately owned e-scooters. This means that:

- It's illegal to ride an e-scooter on public land. This includes roads, pavements, cycle lanes, beach promenades, bridleways, or any publicly accessible land such as parks and car parks.
- You can only use e-scooters on private land with the landowner's permission.

Be careful of scams over the festive season

At this time of year, many people are Christmas shopping or hunting for January bargains but fraudsters are also keeping busy trying to steal your money.

Scammers take many forms, from posing as police officers asking for your bank details and cash, to rogue traders selling goods and services.

Our top tips for keeping your money safe:

- Any police, bank, fraud department or similar will never ask you to transfer money or ask for your personal banking details.
- If you suspect a scam caller, hang up and wait for 5-10 minutes, or phone a friend or relative to clear the line.
- Be suspicious of emails with 'too good to be true' offers and deals.
- Buy securely only make online payments if there is a padlock symbol in the browser.
- Always log on to a website directly rather than clicking on email links.
- Safeguard your details never divulge passwords or PIN numbers.
- Delete any suspicious emails and block telephone calls if necessary.

Don't be embarrassed to report it if you have fallen victim to a scam; these criminals are cunning and can be easily believable.

Burglars targeting your home for cars

In some areas of Devon and Cornwall we are seeing burglars targeting homes specifically for car keys before stealing the vehicle itself.

There are a few preventative measures you can take to reduce the risk of this happening to you:

- Offenders often scout target addresses at night so report any suspicious vehicles or individuals.
- Secure your home overnight; check doors are locked before bedtime.
- Do not keep your vehicle keys in a quickly accessible or visible place. A common factor in these crimes is that car keys were within easy reach.
- If you have a keyless car, consider keeping your keys in a faraday box
- Consider registering your vehicle with a stolen car tracking app - there are several available online.

Winter wise: be safe when driving in colder conditions

Now the colder weather is upon us, it is important to understand how the weather will affect the road and your vehicle.

As a reminder, we've put together a checklist of things you should be aware of when driving in icy conditions.

- If the weather is bad, first ask yourself 'do I need to travel today, or can I avoid it?'
- Clean all ice from your car before setting off so you have clear visibility. Don't forget to check your headlights and taillights.
- It is harder for tyres to grip the road when it is icy or wet, which means breaking distances are much longer than when driving on dry roads.
 Make sure you keep well back from the vehicle in front of you to give enough space.
- The more worn your tyres are, the less grip they'll have on the road, so make sure to check your tyre tread - it should be at least 1.6mm.

How to check your tyre tread:

Place a 20p coin into the main grooves of your tyre. If you can see the outer band of the coin, then your tyres may be too shallow and possibly below the legal limit. If this is the case, they will need to be replaced as soon as possible.
